CALL TO ORDER

NEW BUSINESS

President Beasley asked if anyone had rules changes for the 2010 By-Laws, Rules and Regulations.

- Under Board of Directors add: All delegates must be 21 years of age or older.
- Approved Events: Add Open Walk Trot - 11 years old and over. Same rules as Walk Trot. No year end awards.
- Add Ranch Horse Western Pleasure: AQHA Rules - No horses, less than 3 years of age may be exhibited. No hoof polish. No braided or banded manes or tail extensions. Trimming inside ears is discouraged. Trimming bridle path is allowed, also trimming of fetlocks or excessive (long) facial Hair. Equipment with silver should not count over a good working outfit. Silver on bridles and saddles is discouraged. No year end awards.
